## IRON ACTON BURIAL GROUND

### FEES, PAYMENTS AND SUMS FIXED AND SETTLED UNDER SECTION 34 OF THE BURIAL ACT 1852

The fees, payments and sums set out below apply where the person to be interred, or in respect of whom the right is granted, is or immediately before his death was an inhabitant or parishioner of the Parish of Iron Acton, or in the case of a still-born child where the parents (or one of them) are, or at the time of interment were, such inhabitants or parishioners.

In all other cases the fees, payments and sums will be doubled, except that those set out in Part 1 and 4 will not be doubled where the exclusive right of burial in the grave in question, or the right of constructing the grave or vault, was acquired at the single fee as set out in Part 2 or Part 3.

#### **Part 1 INTERMENTS**

The fees indicated for the various heads of items 1, 2 and 3:-

- a. Do not include the digging of the grave.
  - b. Apply only where the interment is made between the hours of 10.00am and 4.00pm on a weekday or on a certificate of a coroner or registered medical practitioner that immediate interment is necessary. In any other case an additional £20.00 is payable.
  - c. Apply provided that the interment is made within 30 minutes of the time arranged with the Clerk of the Parish Council. If not so made, an additional £10.00 is payable.
1. For interment in any grave
    - i. Of the body of a still born child or a child whose age at the time of death did not exceed one month. £15.00
    - ii. Of the body of a child whose age at the time of death exceeded one month but did not exceed 12 years. £30.00
    - iii. Of the body of a person whose age at the time of death exceeded 12 years. £150.00
  2. For any interment in a vault £150.00
  3. For the interment of cremated remains  
in a grave in respect of which an Exclusive Right of Burial has been granted. £75.00

#### **Part 2 EXCLUSIVE RIGHT OF BURIAL IN EARTHEN GRAVES**

1. For Exclusive Right of Burial for a period of 75 years:-
  - a) In an earthen grave 9ft by 4ft. £150.00
  - b) In an earthen grave 9ft by 8ft. £315.00
2. For the Exclusive Right of Burial of cremated remains in an earthen grave 3ft by 3ft for a period of 75 years. £90.00
